# INVITATION TO BID

## Notice is given hereby that:

Sealed bids will be received by the Imperial Calcasieu Regional Planning and Development Commission until: <u>2:00 P.M. Local</u> Time, on Thursday July 27, 2023 at the SEED Center 4310 Ryan <u>Street, Lake Charles, Louisiana</u>, 70605, whereas bids will be publicly opened and read aloud.

Bids must be accompanied by a Bid Bond or a Cashier's Check in the amount of 5% of the total bid value, said bond or check made payable to Imperial Calcasieu Regional Planning and Development Commission.

On any bid submitted in the amount of fifty thousand dollars or more, a Contractor shall certify that he is licensed under the provisions of paragraph A, Section 2163 of the Contractor's Licensing Law and shall show his license number on the bid envelope.

All work completed in this project shall comply with Executive Order No. 11246 Equal Employment Opportunity.

The successful bidder will be required to furnish a Performance and Payment Bond written by a company licensed to do business in the state, each in an amount equal to 100% of the Contract amount.

No bid may be withdrawn for a period of forty-five (45) days after receipt of bids.

Each Bidder must not maintain or provide any employee facilities that are segregated on a basis of race, color, creed, or national origin.

The Commission reserves the right to reject any and all bids and to waive any informality incidental thereto, in accordance with LA Revised Statutes 38.

The Commission is proposing a pilot southwest Louisiana regional community public roads asphalt overlay project. We have invited all public entities in the southwest planning area to submit a list of roads to be improved by this effort. We have received responses from 9 such entities. They are Jeff Davis Parish, Allen Parish, Cities of Lake Charles, Jennings, Sulphur, Dequincy, Towns of Iowa, Lake Arthur, and Oberlin. A vicinity map of the Region and respective roadway lists are attached. Approximately 40 miles of roadway are included which are estimated to need one of three types of proposed improvement; 2" asphalt pavement overlay with minimal 12" deep patching, 2" asphalt pavement overlay with normal 25% to 35%, and full width roadway base in place cement stabilization with 2" asphalt pavement overlay.

This solicitation authorized by the participating public entities is a **one contract bid** including the roads submitted by all entities that have chosen to be included in this pilot project. It is anticipated that this unification of all roads, bid as one project, will increase roadway contractor interest resulting in more bidders for a greater quantity of work items creating a competitive environment driving down overall paving costs for participating public entities.

The primary target scope of improvement is 2-inch overlay with minimal patching. A 2-inch overlay with heavy patching and full width roadway base in-place cement stabilization with 2-inch overlay is secondary and will be considered on case-by-case basis.

Bidders are to submit a list of individual item units and bid cost to construct per unit item. Bidders are to include all individual items required to improve roads in any of the three scopes of work described herein. All items are to be constructed in the quality required by the latest Louisiana DOTD specifications including any/all supplemental specifications for roadway construction or equal. Bidders are to provide total project bid cost by summing up all unit items times the unit bid cost.
