A RESOLUTION OF THE BOARD OF DIRECTORS OF THE SOUTHWEST LOUISIANA REGIONAL PLANNING COMMISSION (SWLA-RPC) FOR LOUISIANA PLANNING DISTRICT 5 APPROVING AND ADOPTING SIGNATORIES AND AUTHORIZED REPRESENTATIVES FOR THE SWLA-RPC FINANCIAL ACCOUNTS, CHECKS, AND OTHER ACCOUNTS REQUIRING DISCRETION WITH THE SOUTHWEST LOUISIANA CREDIT UNION AS NOTED.


