

RESOLUTION NO. 2324

A RESOLUTION OF THE BOARD OF DIRECTORS OF THE SOUTHWEST LOUISIANA REGIONAL PLANNING COMMISSION (SWLA-RPC) FOR LOUISIANA PLANNING DISTRICT 5 APPROVING AND AUTHORIZING THE EXECUTIVE DIRECTOR TO EXECUTE DOCUMENTS PERTAINING TO THE LOUISIANA OFFICE OF COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAMS.

WHEREAS, the Louisiana Office of Community Development Block Grant Programs provides essential funding for the betterment of our member governments and the region; **AND**

WHEREAS, the efficient administration and execution of contracts, amendments, and project applications is crucial to the success of these programs and projects; **AND**

WHEREAS, it is in the best interest of the member governments of State Planning District 5 and the region to streamline the process for executing documents related to the Louisiana Office of Community Development Block Grant Programs; **AND**

WHEREAS, the Southwest Louisiana Regional Planning Commission Board of Directors is desirous of facilitating several regional initiatives encompassing Community Development Block Grant Programs and Projects; **AND**

WHEREAS, the Board of Directors desires to expedite coordination with public and private entities within the designated regional partners;

NOW THEREFORE BE IT RESOLVED BY THE SOUTHWEST LOUISIANA REGIONAL PLANNING COMMISSION BOARD OF DIRECTORS FOR LOUISIANA PLANNING DISTRICT 5 THAT THE EXECUTIVE DIRECTOR OF THE SOUTHWEST LOUISIANA REGIONAL PLANNING COMMISSION IS HEREBY AUTHORIZED AND EMPOWERED TO EXECUTE ANY AND ALL DOCUMENTS PERTAINING TO THE OFFICE OF COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAMS, INCLUDING BUT NOT LIMITED TO CONTRACTS, AMENDMENTS, AND PROJECT APPLICATIONS ON BEHALF OF THE COMMISSION.


BE IT FURTHER RESOLVED, that this authorization shall extend to any future CDBG programs as well, unless otherwise specified by a subsequent resolution.

BE IT FURTHER RESOLVED, that the Executive Director is directed to ensure that all such documents are executed in accordance with applicable program guidelines and regulations.

BE IT FURTHER RESOLVED, that a copy of this resolution shall be provided to the Louisiana Office of Community Development for their records, and any other relevant parties.
