RESOLUTION NO. 2329

A RESOLUTION OF THE BOARD OF DIRECTORS OF THE SOUTHWEST LOUISIANA REGIONAL PLANNING COMMISSION (SWLA-RPC) FOR LOUISIANA PLANNING DISTRICT 5 APPROVING AND AUTHORIZING A SERIES OF POTENTIAL FUNDING MECHANISMS TO SUPPORT THE PROPOSED SOUTHWEST LOUISIANA REGIONAL MOBILITY AUTHORITY.

WHEREAS, the Southwest Louisiana Regional Planning Commission adopted Resolution No. 2288 in support of the establishment of a Southwest Louisiana Regional Mobility Authority; **AND**

WHEREAS, the Board restricted establishment of the Southwest Louisiana Regional Mobility Authority pending identification of specific priority transportation improvements to be facilitated by such; **AND**

WHEREAS, the Board of Directors recognizes there must and shall be a funding mechanism to facilitate identified needs and objectives of the proposed Southwest Regional Mobility Authority; **AND**

WHEREAS, the Board has considered several alternative funding mechanisms for the proposed Southwest Regional Mobility Authority; **AND**

WHEREAS, there is a survey of financial resource preferences identified by Board members that may support and provide adequate revenue streams for the Southwest Louisiana Regional Mobility Authority; **AND**

WHEREAS, the consensus among members of the Board on preferred alternatives suggested resulted in three options considered for feasible implementation; **AND**

WHEREAS, the responsibility for pursuing the three recommended financial alternatives to fund the Southwest Louisiana Regional Mobility Authority rests with the SWLA-RPC in securing legislative and local government authority to effect same; **AND**

WHEREAS, it is the obligation of the Board to approve, direct and take up the challenge and requests with the legislature and local governments;

NOW THEREFORE BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE SOUTHWEST LOUISIANA REGIONAL PLANNING COMMISSION (SWLA-RPC) FOR LOUISIANA PLANNING DISTRICT 5 APPROVING AND AUTHORIZING A SERIES OF POTENTIAL FUNDING MECHANISMS TO SUPPORT THE PROPOSED SOUTHWEST LOUISIANA REGIONAL MOBILITY AUTHORITY AS FOLLOWS:

2. *SURVEY DIRECTIVE No. 4*
3. *SURVEY DIRECTIVE No. 10*
