

RESOLUTION NO. 2330

A RESOLUTION OF THE BOARD OF DIRECTORS OF THE SOUTHWEST LOUISIANA REGIONAL PLANNING COMMISSION (SWLA-RPC) FOR LOUISIANA PLANNING DISTRICT 5 APPROVING ACTIVATION OF THE SWLA-RPC HOUSING COMMITTEE AS DEFINED IN THE BYLAWS.

WHEREAS, the Southwest Louisiana Regional Planning Commission Bylaws provide for a Board designated Housing Committee; AND

WHEREAS, the Board adopted Resolution No. 2317 establishing a regional housing initiative for Southwest Louisiana; AND

WHEREAS, there is a small budget allocation in the current SWLA-RPC Annual Budget of \$25,000 provided to initiate the regional housing initiative; AND

WHEREAS, the Board is desirous of advancing the regional housing program with interested stakeholders who may assist in the identified housing needs and objectives; AND

WHEREAS, the Bylaws state the SWLA-RPC Housing Committee shall be comprised of not less than seven members and not more than fifteen; AND

WHEREAS, the Bylaws state that members of the Housing Committee are to be preferentially offered to elected officials, but allowable to others with housing related experience; AND

WHEREAS, the responsibilities of the Housing Committee are elaborated in the Bylaws including coordination of housing services and resources such as a clearinghouse for information throughout Southwest Louisiana; AND

WHEREAS, it is the obligation of the Board to approve all members of the Housing Committee;

NOW THEREFORE BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE SOUTHWEST LOUISIANA REGIONAL PLANNING COMMISSION (SWLA-RPC) FOR LOUISIANA PLANNING DISTRICT 5 APPROVING ACTIVATION OF THE SWLA-RPC HOUSING COMMITTEE AS DEFINED IN THE BYLAWS WITH THE FOLLOWING REPRESENTATIVE SEATS.
